ANNEXATION ORDINANCE

WHEREAS, the property hereinafter described is contiguous to the North Shore Water Reclamation District, or is non-contiguous and the owner or owners of record have entered into an agreement requesting the annexation of the non-contiguous property, and

WHEREAS, the property is being served by a sanitary sewer of the North Shore Water Reclamation District or by a sanitary sewer that is tributary to the North Shore Water Reclamation District, and

WHEREAS, said property is not within the corporate limits of any sanitary district, and

WHEREAS, within the meaning of 70 ILCS 2305/28, the NORTH SHORE WATER RECLAMATION DISTRICT has power to annex the territory hereinafter described by the passage of an ordinance to that effect, and

WHEREAS, it is in the best interests of the citizens of the NORTH SHORE WATER RECLAMATION DISTRICT to annex the property hereinafter described.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE NORTH SHORE WATER RECLAMATION DISTRICT AS FOLLOWS:

SECTION 1: That the property hereinafter described to-wit:
